WHAT DOES AHC DO FOR INDUSTRY

Disaster Supply Chain Resilience & Logistics

Persistent regional storms and disasters disrupt supply chain resources (fuel, food, water, materials, medical supplies, etc.), supply lines (road closures/access), and trigger fleet movements of utility restoration crews and across state lines. Multiple delays can occur that require permits, waivers, and other information from government to resolve. This creates a logistical log jam. The AHC fills this gap by leveraging its government relationships to resolve issues via its integrated work groups, year round planning, partnerships and trust framework for secure information sharing that results in expediting fleet movement, coordinated logistics, and resolved supply disruptions.

External Impacts to Internal Business Continuity Planning

Many Business Continuity Plans (BCPs) are dependent upon external factors during large disasters. These dependencies include: Communication protocols with government and other sectors; Finding critical resources (fuel, water, ice, commercial generators, etc..); External facility risk assessment, availability and access. The AHC provides a simple review and assessment to private sector members their BCPs using senior operations professionals who have years of experience in disaster responses and planning.

Trusted, Sensitive Operational Information Sharing & Cyber Security Issues

Sharing sensitive operational information with government is required to resolve many private sector operational issues during disasters. Cyber security and information sharing are closely related. Verifying data user/provider identities is critical to the private sector. Stakeholders use the AHC workgroups, its trusted information sharing framework, and its Cyber/Identity Management partner organizations to address issues with sensitive operational information sharing.

Understanding Operational Dependencies

Public and private sector dependencies negatively impact the private sector supply chains, Business Continuity Plans (BCPs), disaster response, and regulation/compliance efforts. The AHC continually provides education and sustains working groups and partnerships that help stakeholders learn and gain a common perspective on the "big picture" that impacts their organization on many fronts. The AHC manages the process that identifies, catalogs and addresses critical issues via sector focused working groups.
