2. Discussion – FEMA BRIC Grant

Tom Moran provide backstory of the AHC's FEMA BRIC grant project idea for energy resilience.

- Virginia and Dominion Energy
- Create rechargeable industrial batteries on tractor trailers that can be used to support power outages in under-served communities.
- Grant application submitted in Jan 2022
- Award schedule for June 2022

- Dominion funded AHC to create work group and hire grant writers and consultants to submit the proposal
- Phase 1 will be a scoping project for \$1.0
- Phase 2 will be a pilot for up to 10 sites, \$5 to \$8 million
- Phase 3 will be roll out of up to 100 locations

For 2023 applications, the AHC is talking with other potential states and utilities

2) Legal update
