SUBJECT: AUTHORIZATION FOR EMERGENCY RESPONSE VEHICLES TO BYPASS WEIGH STATION FACILITIES IN RESPONSE TO COLD WEATHER EMERGENCY IN THE EASTERN UNITED STATES

Effective immediately, emergency response utility vehicles (i.e. bucket trucks, etc.) responding to a Cold Weather Emergency in the eastern United States are given the authorization to bypass all FDOT weigh station facilities until Friday, January 29, 2016. This weigh station bypass authorization does not include loads that require permits to operate on Florida's roadways.

This effort has been coordinated with personnel with the Florida Highway Patrol and the Department of Agriculture to expedite emergency response.


