### What is RRAP?

The DHS Regional Resiliency Assessment Program (RRAP):

- Is a cooperative assessment of specific <u>critical</u> <u>infrastructure</u> with input and guidance from federal, state, and local partners
- Focused within a designated geographic area
- Provides a regional analysis of the surrounding infrastructure
- Addresses a range of infrastructure resilience issues that could have regionally and nationally significant consequences
- Identifies gaps, produces tools, best practices and recommendations to reduce risk for all stakeholders
