The National Vetted PPE Exchange is managed by the All Hazards Consortium (AHC) which has been working with government and industry for over fifteen years to solve operational issues during disasters and operates the legal trusted framework that operates this service.

The PPE Exchange empowers your members to find the PPE and other supplies they need within minutes, not days. Current users report it reduces their internal sourcing labor costs by up to 80%.
