SISE-net Operation Information Sharing Hub

**A collaborative information hub for simplifying crisis coordination
between states and the private sector powered by a national community**

Benefits

- **Single Point Access** - A one-stop shop for validated operational information and resources.
- **Sync's Situational Awareness** - Gets industry and government on the same page in six areas during disasters.
- **Cross-Sector Collaboration** - Industry and government experts work together.
- **Data Reliability** - Information ranked using the ORL standard for ranking data confidence.
- **Comprehensive Data Collection** - Collects emails, attachments, texts, pics, approved social media posts, and more.
- **Reduced Email Traffic** - Minimizes email confusion and communication chaos.
- **FOIA Protection** - Ensures privacy from non-operational users.
- **Private** - Available only to a vetted community. Not publicly accessible.

Purpose

To sync and simplify communications across all sectors and states before, during, and after a hurricane or crisis.

Overview

Developed in 2020, the SISE-Net Hub is a system that helps industry and state governments work together more smoothly during disasters. It connects them and synchronizes their situational awareness about what's happening in impacted areas in six specific areas, helping them coordinate their efforts to reduce confusion and delays, which saves lives and property.

How It Works

The SISE-net Hub is the technology part of a larger year-round, cross-sector planning and exercise framework supported by industry. The SISE-net community sustains cross-sector planning and exercises between states and industry stakeholders to identify and solve shared operational problems.

- **Planning** - Weekly and monthly planning meetings conducted by working groups.
- **Exercises** - Annual cross-sector virtual exercises held by the SISE-net community and its working groups.
- **Disaster Response** - The SISE-net community accesses trusted and vetted crowdsourced information and data feeds.
- **The Hub** is where unstructured crowdsourced information is converted to GIS format, which can be validated, shared faster, and protected better than emails.

New users register with SISE-net and immediately gain access to the SISE-net Hub via a web browser on any device.

SISE-Net Operational Updates

What types of data are included?

Before Disaster

- DECLARATIONS**: Signed emergency declarations or Executive Orders related to current event, or that can be extended for use with the current event.
- WAIVERS**: Waivers for critical infrastructure sectors that require movement of critical resources beyond normal operating conditions.
- GUIDANCE/ALERTS**: Written guidance, alerts, or updates on government actions within a state on transportation, surfers, wind restrictions, utility removal, construction, closures, etc.

After/During Disaster

- FACILITY STATUS - OPEN/CLOSED**: Status of a specific facility in the impacted area that provide essential services.
- INFORMATION REQUESTS**: Industry request for government support on expanding the flow of information, removing obstacles, clarifying decisions, and other disaster-related situational awareness.
- INFRASTRUCTURE DISRUPTIONS**: Disruptions, interruptions, and/or limitations to normal business operations of critical infrastructure sectors.
